Peter wants to continue discussion on this matter.

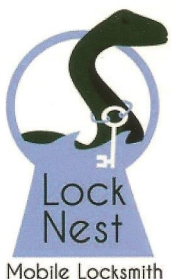

—CLEAN MY MAC X Is Now Everywhere

DURING THE COVID LOCKDOWN, many took to performing chores around the house that had been put off since the Eisenhower Administration (Google it, kids). Spanning the gamut from cleaning the garage, scrubbing the fridge (expiration dates from the last century are not a good thing), and even more. I know of one prominent podcaster and friend who spent a Sunday afternoon cleaning out her toaster. Can *you* do that?

Since you're reading this article, you most likely have started to clean up your Mac: tossing old files, purging various Contacts on your Mac (plus Facebook), and if deranged enough, striving to reach the ever-elusive Inbox Zero.

If so, you're most likely using (or *should* be using) Clean My Mac X from MacPaw. And now, its makers are proud to announce significant news.

Released in 2008 by MacPaw, CleanMyMac has been transformed into a powerful utility that removes clutter, optimizes system performance, and protects Macs from malware and adware. De-

spite being distributed independently from the Mac App Store because of the platform's business and technical constraints, CleanMyMac got 20M+ downloads and at least one user in Antarctica.

CleanMyMac's success allowed MacPaw to become one of the largest independent MacOS software development companies with 10+ applications in its portfolio and a team of 240 humans and two cats. I use CMMX at the end of each working day. It's one of the few actions anchored in my daily work flow.

You can obtain CMMX from MacPaw's site or as part of your Setapp subscription. But as of April 28th, after twelve years, you can purchase CMMX at the Mac App Store (MAS). So, you have exhausted your excuses not to include this indispensable app in your tool kit.

The reason for the overdue entry into the MAS is a reflection of both technical constraints and how software business models are evolving: in 2018, MacPaw released CleanMyMacX and made it available as a one-year subscription in addition to its existing perpetual-license model. The subscription model turned out to work well for CleanMyMac X's customers as it allowed them to receive new major features every few months at no additional costs. The new subscription model could also be implemented in the Mac App Store, which made it possible for MacPaw to bring CleanMyMac X to Apple's platform.

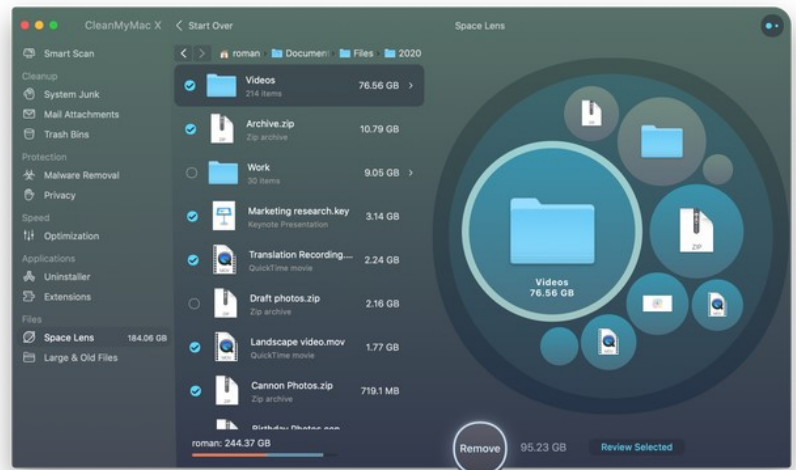
Because the MAS limits privileges of applications to protect your Mac from malicious software, this approach sometimes imposes unnecessary restrictions on safe activities, like cleaning system logs or even updating applications.

Both the MacPaw Store and Setapp versions differ slightly from the MAS one. Particularly, Apple's application review guidelines don't permit some of CMMX features, so they had either to revise or step back from them. Other than that, you still have plenty of tools to give your computer a good scrubbing.

My most recent review can be found [here](#). But CleanMyMacX is ever-evolving. Since that review, it has added several more tools.

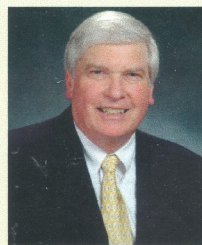

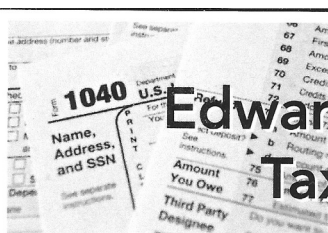

– SETAPP: CleanMyMac X is available on the Setapp subscription service that provides access to 170+ Mac apps for US\$9.99 per month.

Requirements: OS X 10.10 or later, Intel Macs only. A free trial is available for the MAS, Setapp, and MacPaw Website versions of CleanMyMac X.

If CMMX hasn't appeared on your radar, you can kick the tires with a [free download](#) of the MacPaw version (free trials of the other versions are available, as well). Give it a whirl. Then buy it!

About The Dayton Microcomputer Association, Inc. (DMA)

MORE THAN FORTY-FOUR YEARS AGO, a small group of computer enthusiasts from the Dayton, Ohio area gathered around a kitchen table looking at, and playing with, an early personal computer called the Altair 680 that one of them had purchased. This computer had been featured earlier on the cover of the January 1975 issue of *Popular Electronics* magazine. Paul Allen had shown the selfsame article about the Altair to Bill Gates, and later, they wrote software together for that computer. Still later — and still together — Allen and Gates founded the Microsoft Corporation.

Shortly thereafter, those Dayton-area computer enthusiasts joined together with many others to form THE DAYTON MICROCOMPUTER ASSOCIATION (DMA), now one of the oldest (if not *the* oldest) contin-



uously-operating computer user groups in the world. Typically, computer user groups, and the newer iteration, technology user groups, are volunteer-run operations. The DMA is an all-volunteer led, organized, and run 501(c)(3) non-profit organization.

Now, there are hundreds of computer (or technology) user groups in the world, all of which continue to foster improved communication between technological equipment and software publishers, and users of their products. User groups (both computer and technology) provide an environment where more experienced technology users introduce additional and advanced techniques to novices.

DMA offers both monthly General Membership Meetings, which cover new and innovative topics including a wide range of generic, technological topics, and its Special Interest Groups (SIGs) which address concerns about specific technology interests. There are eight different SIGs sponsored by the DMA, covering such topics as the Linux operating system, various programming languages such as Python, the use of technology to investigate genealogy, and digital aids to investing. Neither SIG members nor attendees at DMA General Meetings need be members of the parent organization, though they are encouraged to join so DMA can continue providing its services to the public.

Annual dues for DMA membership, which have not been raised for decades, are \$25 for Regular Members, and \$12.50 for Family/Associate Members (someone living at the same address as a Regular Member). Nonvoting Student Memberships are *free* to students through age 22. Door prizes at General Meetings, picnics, banquets, and other DMA events, and both product and service discounts are available to all DMA members.
