## Microsoft Mobility in Action

I was most impressed the first time, I was introduced to the Tablet PC. I know many people who went to COMDEX and the APCUG conference last fall were not all that impressed, but it might have been a problem with the environment. I saw the Tablet PC for the first time last fall when William Steele gave a very impressive demonstration of this device. He has been most gracious in agreeing to give us all a demo of the Tablet PC, Pocket PC, and the Pocket PC Phone Edition when Microsoft is getting ready to promote the SmartPhone.

As always, Microsoft is hard at work trying to find the best way to help integrators and users with three key groups. *Microsoft Mobile Device News*, *Pocket Watch Newsletter*, and *Microsoft Windows Embedded DevWire* are the trio of newsletters geared to people trying to figure out how to use these new technologies. *Microsoft Mobile Device News* is focused more on getting general information out to users and engineers

who are trying to integrate work tasks. The *Pocket Watch Newsletter* is giving promotions and giving ideas to make use of your new work and play toys. *Microsoft Windows Embedded DevWire* is aimed at developers making applications for integrating all of these different tools that are used in today's workplace.

The Tablet PC is just the tip of the iceberg. The *Pocket PC* and the *Pocket PC Phone Edition*, along with the *Windows Powered SmartPhone*, are all part of the Microsoft Mobility in Action. The Windows XP set of security protocols along with the Office XP set of tools bring about what you will need to make the Tablet PC work. Save a note in your own handwriting, or convert it to a text document. This sounds easy enough but it is William's demo that made me want a laptop computer for the first time. You do not need all of the office tools with the *SmartPhone* or the *Pocket PC Phone*, but if you want to get the improved security, you will want Windows XP.

Running out of paper will become a thing of the past. You can now take all of your notes along with drawings, and most things you can put to a simple pad of paper can be saved electronically in the various handheld devices you can carry. The *Microsoft Windows Journal Viewer* allows anyone with Windows XP or Windows 2000 to view any documents made with the Tablet PC, which can be downloaded at <http://microsoft.com/downloads/details.aspx?FamilyID=fad44098-8b73-4e06-96d4-d1eb70eacb44&DisplayLang=en>. Digital ink handwriting gives one more way for creative people to develop applications using the existing application programming interfaces (APIs). Bill is planning to show us how to build applications. I am sure they will be easy to follow demos for most of us, but Microsoft has a host of sites that allow you to download trial software and follow some of the special training links. Security is

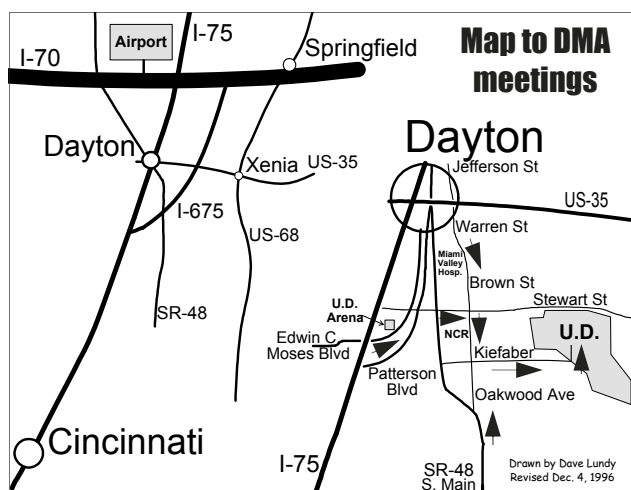

high on the priority list for many people and the Encrypting File System (EFS) is one of the major security features listed for the Tablet PC and Windows XP Professional. A single hardware button to log on emulating the CTRL+ALT+DEL is also a new feature of the Tablet.

This is just the beginning of the mobile family. Between the Pocket PC and the Pocket PC Phone Edition, you can get integration while using just one hand. The infrared and other tools to integrate to a full PC means that you don't have to take a laptop if you have little need for copious notes. Communication can be more important than copious notes and the integration that can only happen when personal communication intervenes and coordinates the imagined with the real. Email, the phone, and text messages are now a real part of the workday, and the easiest way to send messages are with shortcuts that you can use with these Microsoft-empowered tools.

I like my computer on a desk, but even now I have stored away my old three-watt auto phone and have donned the more convenient pocket phone. It is not without some weight, but even I didn't want to carry the three-watt phone around. The three-in-one concept has been laid to waste by the five-in-one concept, and although they are a little heavier, this seems to make sense. Phone, Web browser, PDA, text messaging, plus Paging device is one way to stay compact (Ok, they don't list the Paging; with a phone, do you need one?). They're somewhat larger than the smallest of phones, but big in deliverable services. Microsoft is not saying that these are PDAs, but they are

doing the major work of a PDA with the wireless connection. I still think this is the toy for those people who don't know what to do with all of their copious free time, but they are much easier to carry around than a laptop. The SmartPhone is tuned into today's fast paced environment and can keep you connected wherever you are with a very small footprint.

The SmartPhone includes Pocket Outlook, Pocket Internet Explorer, MSN Messenger and Windows Media Player. And I was thinking I wanted to carry around a big old laptop. This makes use of many needed tools at your fingertips (thumb tip?). Yes, from the Pocket PC through the SmartPhone, it's all geared up to be used with only one hand. Some shorthand coding helps with the one hand operation. I am not sure what all of the differences are between the Pocket PC and the SmartPhone but I am sure we will all find out.

Use voice, SMS text messaging, email, or instant messaging to communicate depending on your situation or environment. Integrated telephony and wireless connectivity mean the choice of communication is yours. The SmartPhone keeps you in touch in many different ways. The unified inbox and synchronization can connect over the air and then integrates with your home or office PC. This sounds like a new way to communicate. Yes, we are moving into a new age where people want to stay awake 24/7. It's 2:47 a.m., should I call Bill and tell him we are ready to see what all the mobile toys can do? OK, I can wait and so can everyone reading this, but let's give William Steele, and Microsoft's Mobile Tools, a warm DMA® welcome.

So far, 421 flavors of the Nigerian email scam have been documented. Variations abound: foreign royalty trying to retrieve government riches from Nigeria, U.S. soldiers extracting gold from Afghanistan.

One of the more creative versions hit in recent weeks, directly targeting both big and small ticket items on popular Internet auction sites.

Here's the con to avoid. A buyer suggests a phony but legitimate-sounding reason to purchase an item with a cashier's check for more than the listed price if the seller agrees to wire the difference back. Weeks later, once the money has been wired to the scammer, the seller's bank learns the cashier's check is counterfeit. Result? The seller is out both the difference and the original purchase price.

Needless to say, a little common sense goes a long way in avoiding 419's clutches. As a general rule, if something sounds too good to be true, it probably is. Still, in only a few years, this basic email ruse has bilked hundreds of millions of dollars from unsuspecting victims, who couldn't resist its innocent-sounding call-for-help and something-for-nothing promise.

# - Marvels Of Technology -

By Jerry Wonderly, regular contributor to *The DataBus*. A native Daytonian, Jerry has been involved with computers since the mid-80's. "I cut my teeth on CP/M Plus." He says that 'computer' can be very expensive but doesn't have to be. "Ask questions. Think cheap. Shop around. And don't assume your computer needs to be traded in. I'd rather put my money in my 401(k) than spend it on a complete new system and software."



There's an oft-used cliché that technology is changing our lives. We've all heard it; we all sigh and nod in passive agreement. Yet in the past month, on a very real personal level, it has really hit me and has caused me to blink in near disbelief at the subsequent changes. Oh, how I wish my parents were still alive to experience some of this. They would be astounded. For example, in the last 30 days I've been unlucky enough to have been attacked many, many times on my PC, lucky enough to save \$130 of \$150 on doorbell installation, retired my wristwatch, contracted for central air conditioning, professionally completed forms, taken my first digital photographs, and most impressively, just watched – live – an actual battle in Iraq's Umm Qasr in the wee hours of March 23 (EST). That was truly an historic moment. Why do I mention all of this? Because I plan to cover most of these topics in this article and hope that some of it may be useful to you too.

First, we'll look at Internet attacks. We all know to use anti-virus software by now. And many of us also wisely use firewall software while we're on the Web to protect us from attacks. But did you know that good firewall software, *if set-up properly*, will also keep confidential information from leaving your computer? Get this: someone out there has been trying to get my social security number! About once a week, I get hit when my browser gets redirected from a perfectly innocent web page and the attempted theft occurs. It may be happening to you without you knowing it. Friends, use a good firewall and set it up right. I use Norton Internet Security 2002. On its Privacy Tab, there is a button called Confidential Info. I've entered all sorts of stuff I don't want to leave my PC without my consent: Social Security Number, phone number, home address, name, etc. Other good

firewalls probably have a similar privacy option. If yours doesn't, consider Norton IS 2002 a good bet. Use a comparison-shopping site like My Simon, [www.mysimon.com](http://www.mysimon.com), to get it at a great price. There may be a 2003 version available too. NIS is also available within a suite of Norton software called Systemworks, which also contains Norton Anti-Virus and an assortment of diagnostic utilities.

Next, if you've been living in the Stone Age without a doorbell like me, save yourself \$130 on a hard-wired installation by getting a wireless one. I got a GE Wireless Chime unit and door button for only \$10 at Wal-Mart. The batteries were extra. It went up so fast and so easily that I could have kicked myself for not doing it years earlier. Next, I plan to tackle an exterior, solar-powered yard light with a motion detector. Ain't technology great?

Why did I retire my watch? Because I have finally joined the cell phone crowd and it tells time. Already, it has really come in handy. On an icy night out in the boondocks, I put my truck in a ditch (my first time ever) and had to call for help. Incidentally, according to Consumer Reports, Verizon Wireless has the best reliability and the best plans if you're considering the cell phone plunge. Shortly, I plan to call Ma Bell and disconnect my landline phone number. Then I'll retire all of those phones. I never thought I'd see the day....

As far as completing forms professionally, I have been testing Abbyy Fine Reader 6.0 Corporate Edition. It is, in my opinion, the finest Optical Character Recognition (OCR) software available. With OCR software, you can scan documents into your PC and edit them. Fine Reader Corporate also comes with a really cool add-on called Form Filler.

It is utterly fantastic. Form Filler is small and simple but has dynamite results. It's a shame it is not available by itself on the retail market. Here's how it works: You scan in the form you want to complete, designate the areas to complete (called "fields"), set your font, size, etc. and presto, your form will print out beautifully. And, the software keeps the blank form as a template for future use. The only drawback that I've seen so far is that you can't clean up the scanned form within Form Filler (staple holes, etc.) There is a work around though by using Abbyy Fine Reader to clean it up first. In a business environment, Abbyy Fine Reader 6.0 Corporate would be a wonderful time-saver. Now let's take a look at how digital cameras have changed our lives. Recently, I was fortunate enough to get one free through my employer's safety rewards program. Not being an avid photographer, I chose an entry-level digital camera called the Olympus Camedia D-380. It is a two-megapixel camera that retails for as low as \$155.00. So what's so cool about digital cameras that you haven't heard before? No, I'm not mentioning the photo-processing savings, the ability to easily import the pics into your PC, or the ability to quickly view your shots. What's really innovative is that you can take snapshots of your woodwork, cabinets, flooring, etc. and then go shopping for accessories or whatever and use the camera's photos as reference materials. For example, I recently took a quick shot of my kitchen, went straight to Lowe's and showed the cabinet folks what I had to work with. They quickly saw the problem and I

## - DMA<sup>®</sup> Participates In Regional Science Fair -

On March 22<sup>nd</sup>, DMA<sup>®</sup> participated in the West District Science and Engineering Fair at Central State University. DMA<sup>®</sup> provided special event judging for computer-related projects. United States Series EE Savings Bonds were awarded to the winners in two groups: grades 7-9 and grades 10-12. This year's judges were Carol Ewing, Dellis Hines, Gail Young, George Ewing, Joe Livorno, John McDonald, Millard Mier III, Susan Kendall, Steve Reiss and Travis Little. They represented DMA<sup>®</sup>'s 12<sup>th</sup> year participating in the Science Fair.

Entries considered for judging were not only traditional computer and programming projects, but also non-computer projects that utilized the computer in a meaningful way. This meant that a math or biology project in which the student wrote a program to interpret the data was eligible for judging. Over a dozen projects were judged before finding our four prize-winning entries.

First Prize in the senior division (\$1000 in US Savings Bonds) was awarded to Brian Lauber of Chami-

nade-Julienne High School for his project "Infinity Shift and Independent Systems." Brian wrote customized C++ code under Mandrake Linux that helped him graphically map the mathematical theory of Infinity Shift and Independent Systems.

Second Prize in the senior division (\$400 in US Savings Bonds) was awarded to Justin Dierking of Carroll High School for his project "Laser Vision." Justin built a laser triangulation system and interfaced it to his computer utilizing a home-brew interface. He then wrote a Turbo C++ program to find objects within the field of view of his laser imaging system.

Third Prize in the senior division (\$200 in US Savings Bonds) was awarded to Christopher Pitstick of Carroll High School for his project "Search Algorithms, A Comparison." Chris wrote a C++ program to determine the shortest path between two points and around obstacles.

First Prize in the younger division (\$400 in US Savings Bonds) was

awarded to Sean Gleason from Saint Albert's School for his project "Linux vs. XP." Sean analyzed the performance of the two operating systems to determine which operating system was faster in typical applications.

Certificates of award were presented to each of the winners at a ceremony immediately following the Science Fair in the Robeson Auditorium at Central State University. All four prizewinners were present at our March DMA<sup>®</sup> General Meeting. Brian Lauber and Christopher Pitstick were introduced to the members. All were offered student memberships in DMA<sup>®</sup>.

This year's prize awards were set by the DMA<sup>®</sup> board and were approved as part of the 2003 budget. Our prize awards were 33% less than at the 2002 science fair. Next year's Science and Engineering day will present a challenge as it falls on Computerfest<sup>®</sup> weekend. If you are not a Computerfest<sup>®</sup> volunteer, please consider volunteering for the Science Fair. DMA<sup>®</sup> needs you!

## - Windows Tip: Burn CDs in Windows XP -

Discover the freedoms and limitations Microsoft has given your burner with XP.

Windows XP's integrated CD burner is powered by the Roxio engine but lacks the familiar Easy CD Creator interface. There is no CD Burner icon on the desktop or in the start menu. So where is this promised CD burner? There are two answers, depending on if you want to burn audio or data CD's.

### To burn data CDs

Open a folder. Look at the folder op-

tions on the left of your screen. You should see an option to *Copy All Items* to CD or *Copy to CD*, depending on your folder view. You can also right-click a file or folder and choose *Send To* and then CD drive. I appreciate that XP has made it as easy to drop files to a CD as it is a Zip disk. It does not copy the files immediately. Instead, it places them into a repository and waits for further instruction on when and where to burn the CD. Now, place a blank CD into your CD drive or navi-

gate to your CD drive in My Computer, and choose *Write the files to a CD*.

### To burn music CDs

The Windows Media Player was always a monstrosity, and now it now includes a new function -- CD burning. Select a song in your *My Documents* folder, and choose *Copy to Audio CD* from the folder options on the left. Surprise! Up pops the Windows Media Player, waiting for you to choose *Copy to CD*. Hit the record button, and have a good time.



# - Software Review : Avernum 3 -

Spiderweb Software's world of Avernum takes place in a fantasy setting. As the story goes, there is a cruel Empire on the surface, ruled by a tyrant. The Empire discovered an immense network of caverns far below the surface, which they called Avernum. They decided to magically transport anyone they didn't like down there. Instead of dying, these people used magic and hard work to survive in the caves. Eventually, the Avernum refugees found a way to assassinate the Emperor, and later won a war against invading Empire forces. This brings us to the present. The people of Avernum have finally started thinking about returning to the surface world for good. Your party of adventurers is one of the first to go above ground to scout out a remote section of the Empire and see if it is acceptable for settlement. However, rather than finding everything fine and dandy, there are monsters everywhere. Even the Hill Giants and Troglydites, long thought to be extinct, have reappeared. This entire section of the Empire has been magically cordoned off, and it is your job to find out what is causing the monster plagues before they completely destroy the area.

My first impression of the game was that it was very similar to Avernum 2. This is not a bad thing, since Aver-

num 2 was very addictive, and I felt that it was a memorable game. The interface is very much the same; players encounter many of the same races, and even some of the same people from Avernum 2. However, as I played, I also noticed some differences. Avernum 3 is nearly as big as Avernum 1 and 2 combined. There are some new lighting effects. During your adventuring, you can find maps that will help you in your travels. Since a majority of the game takes place on the surface, players will encounter a variety of creatures never before seen in the previous games. Also, you will see the changes between day and night, which go beyond a simple change in illumination. Some creatures only come out at night, for instance.



Gameplay is rather straightforward, much like the classic Ultima style of role playing game (RPG). A lot of time is spent exploring, doing side quests, talking to characters met along the way, and searching for powerful artifacts, weapons and ar-

mor. There is a lot of text in this game, so in some respects it could be described as an interactive book. For example, there are many side quests you won't even find out about if you don't talk to people in various towns and cities. One of the most satisfying parts of the game involves building up your characters. As you complete quests and defeat monsters, you gain experience points. These can be spent at various training locations to improve certain aspects of your characters, such as hit points, defense, agility, etc. By deciding which abilities and special skills to focus on, players can shape their party according to their favorite style of play.

Summary: Avernum 3 may not focus on eye candy, but it has the substance that makes it a fantastic fantasy RPG. Offering even more variety and a larger world to explore than its predecessors, it would be a great choice for anyone who likes adventure or classic role-playing games.

## - Technology.talk — War -

During the 1991 Gulf War, the Dayton Daily News carried an op-ed piece by an officer of the U. S. military. The veteran remarked that motion pictures and TV did not, could not, adequately and completely convey the nightmare of going into battle, of taking a bullet and surviving or watching a fellow soldier take one and drop dead on the spot next to you. "War is hell," he wrote, "movies aren't".

Then, in 1994 and 1998, came "Saving Private Ryan", "Pearl Harbor" and "The Thin Red Line". "Private Ryan" attempted to show the blunt brutality of war, while "Pearl Harbor" tried to illustrate war interrupting and intertwining with human relationships. To a degree, they were successful, but there was something missing.

That 'something' was an exploration of the psychological complexities of war. Having been part of a twenty-one gun salute team at too many funerals for dead 20 year olds in the late '60s and early '70s, I have some experience with seeing, up close, the blank, still disbelieving frozen stares of 40 year old mothers dressed in black, accepting folded American flags, the last physical icons of their deceased sons. Terrence Malick's magnificent "Thin Red Line" nailed that 'something'.

But it was still a movie. Now, minute by minute, we watch yet another conflict, this one very real, being played out for many reasons, some stated, others not, most we know, some we can only guess at. Television parades endless images of explosions, troop movements and generals answering what end up being the same set of questions, around the clock. But we are still disconnected as we sit down

to dinner, gaze at the sound bites and video clips and try to humanize and understand them.

That's what we see on this side of the Atlantic Ocean. Over here, CNN, Fox and the traditional networks offer expected, and filtered, video and commentary. Over there, it's another story, literally and figuratively.

Al-Jazeera, the principal among many Middle Eastern equivalents of CNN, telecasts a different, also filtered, perspective. What al-Jazeera runs is chilling and intriguing. To them, we are not liberators but aggressors. Our laser-guided bombs will be answered, they say, in time, if not in kind.

With the advent and ubiquity of the Web, the curious among us can read other points of view. Al-Jazeera has, at least for now, <http://english.aljazeera.net/>. Many of our citizens bristle at that site's content and slant without admitting (or even realizing) that <http://www.cnn.com/> and <http://www.foxnews.com/> also possess their own slants.

The governments in charge want their citizens to feel as if their respective sides are winning. Having taught marketing and global politics at the university level, I am aware that both are at full throttle regarding the current war.

But there's more. With the Web, there always is. A trip to <http://www.bbc.co.uk/> provides a less impassioned, yet no less complete, aspect of the hostilities. Or, check out the Jerusalem Post, <http://www.jpost.com/>. Or the Sydney Morning Herald, <http://www.smh.com.au/>, from down under.

The journalistic world, with its rain-bow of coverage, slants and opinions, is at your fingertips at [http://www.ajr.org/News\\_Wire\\_Services.asp?MediaType=9](http://www.ajr.org/News_Wire_Services.asp?MediaType=9). If we are to (care to?) understand the full impact of war, we should have all viewpoints. If we want to survive intact, we must.

We have the luxury, for now, of punching the OFF button on the remote and heading for the mall. Clean. Tidy. Safe. Ten thousand miles out of harm's way. But Islamic extremists have warned us that they intend to bring this fight to our streets. They've done it twice, at the same location. The first failed; the second did not. The irony could be that our future headlines will be their current ones and vice versa. It's all in the perspective. And location. And intent.

Not even Hollywood, revered or reviled, can script this future. Terence Malick's masterpiece might be required viewing before it's all said and done.

## - Heartland Regional User Group Conference @ Computerfest® -

### **Held Back This Year—To Be Better Next**

On Monday, March 3, 2003, due to the lack of sufficient advance registration, the DMA® Board of Trustees voted to cancel the Heartland Regional User Group Conference scheduled for Friday, Saturday, & Sunday, March 14, 15 & 16, 2003. Much thought and deliberation went into this decision. With the cancellation of the conference, it was thought that DMA® would be able to focus on providing much better and more extensive future conferences. It was also thought that vendor/sponsors would be less likely to return to future events if this year's conference was conducted with low attendance.

### **But There Is Good News**

Even though the conference was cancelled, there is still good news to be heard about the benefits gained. Because of services offered to visiting User Group leaders, for two years in a row the Heartland Conference has brought people into Dayton for Computerfest® who would not have otherwise attended. Last year we know of approximately 30 people who visited Computerfest® for the first time, and this year, even with the conference cancelled, approximately 15 people did the same.

This year, in addition to attending Computerfest®, people came to Dayton from Michigan, Pennsylvania, California and elsewhere in Ohio for an unofficial User Group Gathering (pizza party) on Friday, March 14. Had the event not been cancelled, User Group leaders would have come from Tennessee and Maryland as well (two new states to be added to the list of eight states already represented by Heartland Conference attendees).

The Heartland Conference volunteers all agree that with much more advance planning and much more sup-

port from other DMA® entities, as well as other User Group support, future Heartland Conference events will attract many more User Group leaders—not only to attend the Heartland Conference, but also to visit Computerfest®. In the future, we see User Group leaders coming to attend the conference and Computerfest® with many of their User Group members following them to Dayton just to buy at Computerfest®.

Even though the conference was technically cancelled, we still wanted to do something to welcome visiting User Group leaders to Dayton and to Computerfest®. The staff and facility of the intended Heartland Conference venue, the Dayton Airport Hotel, was much better than the venue of the previous year's conference and many User Group leaders chose to stay at the Dayton Airport Hotel—even with the event's cancellation. The Dayton and Montgomery County Convention and Visitors Bureau provided us with welcome bags to give to visiting User Group leaders. Free attendance to Computerfest® was offered to those who had sent in their Heartland Conference advance registrations. The Dayton Airport Hotel, OTAP, GE-MAIR, and Heartland Conference volunteers all worked together to furnish a hospitality room with three computers, each with a phone line and Internet account, so User Group visitors could check their email through their ISP's web sites.

Next year, the Heartland Conference can have (because of a generous offer from visiting User Group officer **Charles Isaacs** of the Columbus Computer Society), on-line registration as well as a method to accept fees paid via credit card. The only cost to DMA® would be the low percentage fees charged by the participating bank. There would be no "sign-up" fee charged to us for this service. We have had individuals

from other User Groups volunteer to make presentations, but this is the first time we have had an offer to participate in the improvement of the event's infrastructure.

This year's willing presenters from out-of-state User Groups were **Susy Ball** of the Fresno (California) PC Users Group and **Dave Kindig** of the York (PA) Computer Users. Willing presenters from Dayton were: **Bob Esch, Carol Esch, Carol Ewing, Chris Fidelibus, Matt Scheurer, and Gary Turner**. Chris, Matt and **Dean Halladay** set up the Dayton Airport Hotel's hospitality room computer network.

The key conference volunteers who proved invaluable at working to organize this event were **Leah Day** (Registration Committee Chairman), **Robin Campbell** (Webmistress), **Paul Bullock** (conference Co-Chairman and Vendor/Sponsor Committee Chair) and **Jennifer Bullock**, (Media Designer). Even though the full conference didn't take place (the unofficial User Group Gathering replaced it this year), a large amount of volunteer time, talent and energy generously offered by these individuals made the Heartland Conference a noble effort.

I am willing to advise the next event's chairman and, most importantly, look forward to working with these fine individuals again. Without their considerable efforts, we couldn't have provided services to User Group leaders nearly as well as we did.

## - Amateur Radio Goes High Tech? -

By George Ewing, And Dave Lundy DMA® SIG Members

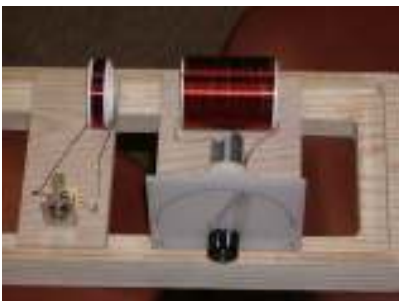
At our April 1st meeting we had the pleasure of seeing what might be the largest Crystal Radio set built. Bruce Lundy KA8EDE & Ed Garner WR8A demonstrated their 'high tech' versions of the crystal radios a lot of us played with as children. My brother Bruce (KA8EDE) has been quite interested in amateur radio for about as long as I have been interested in personal computers. Although Bruce does own a PC, he uses it almost exclusively for e-mail and web browsing. My experience and interest with radio, except for my four years of repairing radios and transmitters in the Air Force, has been mostly restricted to

listening to commercial and public radio broadcasts. I occasionally help him raise or lower an antenna, and designed a digital keyer and software to program an EPROM for a beacon he built.

When George Ewing announced the start of the DMA(R) Amateur Radio SIG, I thought that would be the perfect way to get Bruce more involved with PCs, but he wasn't interested. And I still wasn't interested in pursuing amateur radio. Last summer Bruce had an article published in the Xtal Set Society newsletter about a rather unusual crystal set he built after seeing a similar set built by his friend Ed Garner (WR8A). He has occasionally gotten e-mail requests for more info about his design. That eventually led to me creating a web site [www.gemair.com/~blundy/](http://www.gemair.com/~blundy/) for Bruce to show off his projects. I mentioned it to George and he was fascinated, so George asked Bruce if he would demonstrate it at one of the Amateur SIG meetings.

Well, Bruce loves to talk about his projects (he IS a ham, after all), so it was arranged for the April 1, 2003 meeting.

In spite of George's considerable promotion of the meeting, attendance was only slightly over a dozen. Since I'd not attended before, I don't know if that was high,

low, or average for that SIG. But I do know that those present seemed to be quite interested in the discussion and demonstration by both Bruce and Ed. Bruce started by telling how Ed had been bragging about the excellent selectivity he had been experiencing with a crystal set he had built. Ordinarily, crystal sets are not known for good selectivity (the ability to tune out all stations except the one of interest). With most crystal sets, you will typically hear several stations simultaneously.

Finally, Bruce invited Ed to bring his set over for a demonstration. As soon as Bruce saw it, the secret of its selectivity was evident - high Q coils and adjustable coupling between the input and detector stages to avoid overloading. Bruce enjoys a challenge, so decided to see if he could improve on Ed's design. If you've ever built a crystal set, you

### Bob “The Cheapskate” Click, Greater Orlando Computer User Group



I attended part of the FACUG (Florida Association of Computer Users Groups) weekend conference and it was again very successful. There were about 185 attendees from about 25 user groups, and 61 were first time attendees. Vendor support was down drastically this year with only ten in all. However, the whole event was just as successful. Unfortunately, the Heartland regional in Dayton, Ohio had to be canceled.

Last month I mentioned that the cheapskate would use AARP's free income tax service. Maybe that was a mistake. I took my data and papers there and was surprised to find that the volunteers in this senior center do it by hand, not with computers, but they recheck each other's work. While it was being done, I asked my volunteer about their regular profession and was told the person was an attorney and a CPA. I felt I was in good hands. When it was finished, I took it home ready to mail it out quickly. Out of curiosity, I decided to use the FREE TaxAct software just to see how close I would have come to the figures the tax person ended up with, and to see just how easy it might be that way. I also made the assumption that I might not be so squeamish about doing it myself next year.

I downloaded TaxAct and installed it, then spent a couple of hours answering all the questions, finally ending up with their version of my income tax return, but there was a big difference! Not just a few backs, but my TaxAct version showed over \$2200 more income, and I used the very same W2s and 1099s that I gave the tax preparer. Also, as you might expect, about \$75 less refund, and I would have to pay tax on over \$2000 of our Social Security income, contrary to what I had been told. My wife and I both checked everything over and over, and could

not see what might be wrong with either one. I finally decided to use the TaxAct one because I felt there must be a mistake in the preparer's, so since I had the TaxAct version all filled out, and the income was higher, I went ahead and filed my TaxAct return electronically (with much trepidation). I had my refund back in 10 days with no changes, much to my relief. I'll write a review of this experience, and about TaxAct, and post it on my Web site. I think the preparer made a mistake in the math, but have not tracked it down it yet.

It goes quite fast though, so pay attention and have plenty of time because of all the information it contains. I doubt you will finish it in just one session. Gene's Educational CD is a real bargain.

#### **\*How Much Hot Water Does It Take To Get Hot Water?**

Does that title sound confusing? Perhaps, but when you are in your kitchen, or maybe your guest bathroom, how long is it before the water gets hot when you turn it on. My house is a very inefficient design when it comes to the hot water. My water heater is located in the garage and the only room with a close proximity is our master bath. Other areas take forever to deliver hot water, and during that time, a lot of water goes down the drain, but not if you install a Metland D'Mand system.

This is not a computer-related item, but it is a great product and could save many of you money over the long term. I wrote this item up a few years ago and purchased one myself. It was an excellent decision. The Metland D;Mand system is a small circulation pump to install just below the water faucet furthest from the hot water heater. By pressing a button (both electrical and wireless remote included), the pump starts running and circulates water in the hot water line back though the cold water line into the hot water tank until the pump's sensor detects hot water, whereon it shuts itself off. Motion sensors could also activate the pump. This small pump uses very little power and doesn't run long, preventing you from

wasting water down the drain while waiting for hot water.

Both my wife and I love ours and you can find out much more about the product by checking their Web site [ <http://www.gothotwater.com> ]. Don't forget to read the government agency write-up about this fine product. I've had mine for four years and it's been trouble-free. I had no problem installing it myself with the kit provided, even though I was very squeamish at first since I'm not a plumber. You can hardly hear this pump work during the short period its on. Be aware that you might also need to install a new electrical outlet for it.

## NASA Speaker Addresses Schools

Inge gave a slide show and lecture titled "A Journey Through Space With The Hubble Space Telescope" which displays Hubble photographs showing the wealth of objects in our Universe, the processes they undergo, and the relationships between them. At some schools, she met with students afterwards in smaller focus groups. Her lecture was captivating and was greatly appreciated at every school she visited.

Inge is a senior data analyst with the Hubble Space Telescope at the Space Telescope Science Institute in Baltimore, MD. She was in Dayton as a guest of Computerfest<sup>®</sup> where she presented a total of four presentations on Space and Space Exploration. Inge works on images obtained by the Hubble Space Telescope's Wide-Field and Planetary Camera 2. ## - Sheet Addition with Excel 97/2000 -

by John Heenan, NOCCC -

For Excel 97/2000 users, if you need to add more worksheets to an existing workbook, don't worry, you can add worksheets without doing any harm to existing data, but here's one peculiarity: Let's say that your current workbook has three sheets. These sheets are named Sheet1, Sheet2, and Sheet3. To add a new sheet that is to be named Sheet4. Right-click the Sheet3 tab and choose **Insert | Worksheet**. You'll get a new sheet named Sheet4, but it will appear between Sheet2 and Sheet3. Excel inserts a new sheet before the selected sheet. But you wanted it after Sheet3, right? So, use the left mouse button to grab the new Sheet4 tab, then drag it to the right of the Sheet3 tab. You'll see an arrow appear to show you the new sheet placement. When you release the mouse button, Sheet4 will appear after Sheet3.

**Make Excel Worksheets Fit Your Paper** - Large worksheets in Excel can make for cumbersome printouts, with rows spreading across several sheets and pages breaking in the wrong places. To get the hard copies you want, select **File | Page Setup**.

In the Page Setup dialog box, select the orientation for the worksheet Landscape orientation is better when the number of columns exceeds 20. In the Scaling section of the dialog box, click "Fit to," and then use the arrows to indicate the number of pages wide and number of pages tall the worksheet should be. At this point, click the Print Preview button to check the results.

Click the Zoom button in the Print Preview window. If you can't read

the worksheet on screen, you probably won't be able to read it on paper. You've squeezed your worksheet into too few pages. To change the number of pages, click Page Setup button. If the worksheet does not fit properly, go back to the worksheet and adjust column sizes.

To check the position of page breaks, click Page Break Preview while in the Print Preview window. Scroll down until you see a blue line indicating a page break. If it's not where you want it, click and drag it up. (You can't drag it down.) Click **File | Print Preview** to return to the Preview window. When you're satisfied, click Print in the Preview window or the Page Setup dialog box to put your worksheet on paper.

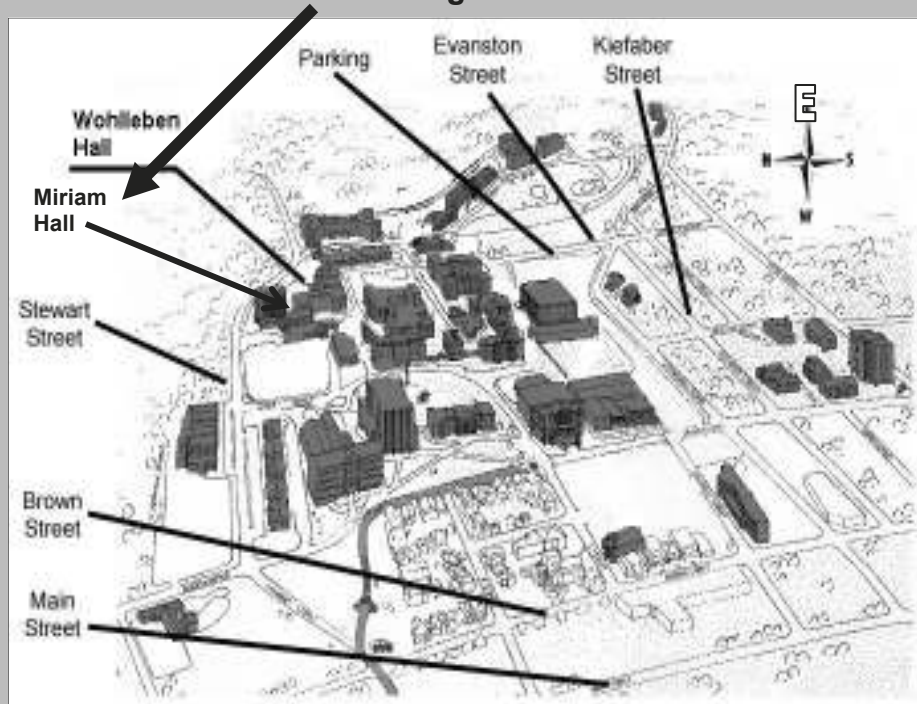
### Location Change!

## Digital Photography SIG

You can even use it to cut DVDs (assuming that you have a DVD burner). Time permitting, we may also take a look at Adobe Premiere 6.5, a professional grade program that allows even more options! The meeting runs until 9:00 p.m., after which we will adjourn to a local eating establishment. This will be a great meeting and will serve as an introduction to any would-be videophile!

The June meeting will be held on June 6<sup>th</sup> at the same location. It will be hosted by Joe Solch and will give an overview of creating Video CDs

(VCDs) with slideshows of your favorite pictures that can be played on most DVD players. This is a great way to share your digital photos with those who do not use computers!

Our April meeting was held on April 3<sup>rd</sup> and featured photo editing using Jasc's Paint Shop Pro (<http://www.jasc.com/products/psp/>) software. There were 34 people present.
