

- Miscellaneous Windows Tips -

Function Key Fun (the F keys)

All keyboards should come with at least 12 function keys.

When you're working inside Windows, you can think of the F keys as nothing more than shortcuts to help you navigate around the operating system without using your mouse.

The F keys also usually serve some purpose when applied to a specific program or piece of software. But don't think because an F key does something in one program that it will automatically do the same thing in another.

What do the F keys do?

F keys are most useful when used with Windows Explorer. Keep reading to find out all about F keys and how to use them. In order to demonstrate how some of the F keys work, you are first help.

going to need to open Windows Explorer.

Go to Start button, Programs (or All Programs if you're using XP), and select Windows Explorer. Or use this shortcut: Press the Windows button + E on your keyboard.

Once you have opened Windows Explorer, then give some of these a try:

F1 If you want to get help while working in a selected program just press this key. If you press this key while working outside a program (like Windows Explorer or from the desktop) you'll launch a Windowsspecific help program.

If you want to get Windows-specific help while working in a program, just press the Windows button + F1. Press Shift + F1 to launch "What's This?" help.

F2 After navigating and highlighting a file or folder in Windows Explorer, just press this key to rename an item. It works just like right-clicking on a file or folder and selecting Rename. When you're finished renaming an object, just press Enter to move on.

F3 Press this key while working in Windows Explorer or on the desktop to generate the "Find Files" window. After searching for a file or folder, just close the Find Files window and go back to what you were doing.

F4 Press this key to open the Address bar in Internet Explorer. To close an open window press Alt + F4.

F5 Press this key to refresh your active window in Internet Explorer or Windows Explorer.

F6 Press this key to move the cursor around the structure of the Windows Explorer and Internet Explorer.

- Linux: What Have I Gotten Myself Into? -

The After-Installfest Panic

OK. You read my last article and decided to take the plunge. You attended the Linux Installfest and installed Linux on a machine. Everything looked good at the Installfest and one of the members gave you a quick rundown of the features. Then you took your machine home....

So here you are facing a login screen and you can't remember your login. Or, you do remember but your screen looks nothing like the Windows you are so used to.
Where do you go from here?

Let's back up a moment. When you did the install on your system, you were asked to set up two users, root and a personal ID. Hopefully you wrote down the password for one of these somewhere. You can use either to get past the login screen. Which should you use? Well, we recommend that you only use root as a last resort. You should be able to do just about anything from the userID you set up. If you are using Windows XP, you will be familiar with the "user" concept. If you are not, well, this is just one of the new things you will have to get familiar with.

Linux is based on Unix, and Unix is a multi-user system. That means more than one person at a time can be logged in. Because of that, Linux has some of the tightest security around.

One of the first differences between Linux and Windows is that Linux does not have a C: drive. Everything in Linux is a file. The top directory (or folder in Windowsspeak) is "/". This corresponds to the "My Computer" icon on the Windows Desktop. Underneath "/", you will find a series of directories.

We'll talk about the specifics of each later. For right now, we will just be concerned with "/root" and "/home". When you log in as root, your working directory will be the "/root" directory. This is the only ID that has its own top-level directory. All other IDs are located in the "/home" directory. So, if you set up a user ID for John Doe as "idoe" then you would find all the work files in "/home/jdoe". Often, when you do the installation, you will find the /home directory is located on another disk partition. This is so the OS can be updated without destroying the personal files of the users.

So let's log in under the user ID. If you told Linux during the install to go to a graphical login, then you will automatically go into XWindows. If you didn't, you might end up at the command prompt. Don't panic! I know it's been a while since a lot of you have even seen a command prompt, but at one time they were common. You can still get the command prompt in most Windows-based machines. For today though, we will go into the XWindows system and save the command prompt for a later article. Just type "startx" at the command prompt and you should load XWindows.

So what is XWindows? Well, the X stands for Xerox, as in Xerox Palo Alto Research Center. This was the great "think tank" of the '80s that was so influential in the systems we have today. Steve Jobs created the Macintosh after having a tour of Xerox PARC. XWindows is the program that provides the windowing system. There is more involved for this article and we'll save the details for later.

Hopefully, when you installed your Linux system, you picked KDE or GNOME as your desktop. These are commercial packages that control the look and feel of your desktop. They also come with some built-in utilities that are quite useful. We will explore the KDE desktop. GNOME is similar enough.

As you look at the KDE desktop, it should look familiar to you. There are a series of icons on the desktop. You will notice at the bottom of the screen something that looks like a taskbar, and over on the left hand side is a "K". The "K" kind of corresponds to the Start Menu on a Windows 9x or later box. The icons on the top indicate your home directory as well as your floppy and CD drive. There may even be a trashcan.

If you double-click on the home icon, you will see the contents of your home directory (or, in the Windows vernacular, folder). This is where all your settings and personal documents will go. There should already be a couple, including one for your desktop.

Next, click on the K on the task bar. You will find a menu already set up for you. There are quite a few entries and many of them will seem to be duplicates. Don't let that bother vou. Just click or hover over each menu selection. You will find that the Internet menu will have applications associated with the Internet. This would include Konquerer, the KDE web browser. You might also find KPPP. If you do, this is where you will set up your Internet access if you will be dialing in. Editors will have several text editors for you to try. You might find a few that even look like Word. The System menu will include those appli-

(Continued from page 6) cations that tell you about your system and help you to configure it. You will notice that most of the Linux applications have the kind of names that only a geek could love. This is another thing that discourages people. Spend some time working with the various applications. As you learn what each one is, you can change the name on the menu with one of the configuration tools.

Now let's look at the "taskbar". In KDE, this is referred to as the panel. You can add and subtract applications to configure your panel if you want. For now, let's just look at what's there. The first thing you should notice is the icon that looks like a computer monitor with a shell

on it. This is your command prompt. It's just like the MS-DOS prompt in Windows. Next, notice the monitor with a circuit card. This is the KDE control center. The Control Center will help you configure your KDE desktop. There are some other icons and you can click on them to see what they do.

At this point, you should just spend some time exploring the system. You didn't learn Windows overnight, and you won't learn Linux overnight either. Perhaps you should try out the various games that come with the system (wasn't Solitaire one of the first things you tried out in Windows?). Next, write a letter. If you feel comfortable hooking up to the Internet, give KPPP a try.

As you use your Linux system, write down the various questions you have. And you will have questions. Bring them to the next Linux SIG meeting on August 21st in the Russ Engineering Center at Wright State. Or come to the Linux Playground during Computerfest®. You can show what questions you have and you can ask a lot of questions. There are plenty of places to learn.

You may still be frustrated and be inclined to just go back to Windows. I encourage you to fight that impulse. Anything that has you doing things differently will take some time. Stay with it and I assure you, you'll get to enjoy your time on Linux.

F7 Only works inside a program.

F8 Press this key to access Windows Startup Menu during boot up. (Like Safe Mode).

F9 Only works inside a program.

F10 Press this key to activate the menu bar in programs.

Press Shift + F10 to bring up the shortcut menu. This works similar to the Application key.

F11 Press this key to open your current Internet Explorer window to "full screen," completely filling your monitor and making all of the toolbars disappear at the top.

F12 Only works inside a program.

Run Old Windows Programs in XP

If you're having trouble running older programs originally developed for previous versions of Windows, you're not out of luck. Luckily for consumers, Microsoft built Compatibility Mode into XP. Compatibility Mode allows you to run a program using the shell of the original program it was developed for.

Here's how to access a program's Compatibility Mode in XP:

- 1. Find the executable or program shortcut icon you'd like to run.
- 2. Right-click the icon and select Properties.
- 3. Click the Compatibility tab and place a checkmark next to the text labeled "Run this program in compatibility mode."
- 4. Select the operating system that the program was originally intended to run on.
- 5. You may need to fine-tune the three fields under "Display Settings" if an older program requires 640x480 resolution or 256 colors.
- 6. Click Apply.

Try starting the program after making these changes. If it still gives you

trouble, try a different operating system. If the program was written for Win 95 and worked fine in Win 98, there's nothing that says it won't still work fine with Win 98.

OK, that's all well and good, but what happens if you try to install a program and it won't even install? Well, we found out that you can do the same compatibility trick with setup programs To do it, put your CD into the drive. If XP brings up the "What do you want to do with this CD?" window, tell it you want to "Open folder to view files" (If it autoruns, cancel out).

If you don't get the option to "Open folder to view files" that's OK. Just hit the Start button, My Computer. Then right-click the CD ROM drive, and select Explore.

OK, you should be looking at the CD ROM's files. Look for a file called Setup.exe (you may not see the .exe). Right-click it and select Properties.

- Game Review - Strategic Command -

World War II was the widest ranging war in history, with parts taking place in various hemispheres. It involved numerous charismatic leaders, generals and heroes. The largest tank battle in history took place during World War II, and the airplane finally came of age as an important part of military strategy. It added words like 'blitzkrieg' to our lexicon, and also gave us the atomic bomb. Because of all these factors, and the appeal of trying out

"what if" scenarios, it is not surprising that battlefront.com has released a WWII game, Strategic Command: European

Theater.

Strategic Command is a good simulation of the war, from the area east of Moscow all the way to the U.S.A., and from 1939 to 1946. It covers the traditional areas of activity for the war but still leaves room for a lot of things that could have hap-

pened. For example, playing as Germany, I invaded the Baltic States early in the game, prompting a much earlier than expected entry of Russia into the war on the side of the Allies. The Baltic States looked tempting - but I hadn't There are a lot of things to like about realized that the Soviets had plans to annex them in less than a year, and they didn't take kindly to my interference. As another example, playing primarily as France and England (Allies), I decided to invade the Low Countries in order to more easily sidestep German defenses. This action seemed to delay the entry of the U.S. into the war, costing me dearly.

Game play is turn based, with all of the Axis troops making their moves, resupplying and entrenching, and then the Allied side getting their chance to do the same. Players can choose which

many other factors, such as fog of war. They can also choose to start play at the very beginning (1939), or else at a number of other pivotal points along the way. This allows a choice between a rather long game and much shorter ones. Players improve their lot by increasing the number of Military Production Points (MPPs) that they collect each turn. Cities, ports, mines and oil sites are all worth various amounts of



MPPs each turn. MPPs can be used to purchase new units, heal damage taken during combat or to research new weapons such as jet aircraft or sonar.

this game. It is very easy to pick up the basics quickly, but like Othello, it takes a while to master. With all of the user configurable options, you can play several hundred times and play will still seem fresh. As your skills improve, you can increase the difficulty setting. causing the computer AI to represent a true challenge. I truly love the research options included in this game. As time goes by, you can begin producing new classes of improved tanks and aircraft a feature that has been missing from many WWII games I have played previously. This also causes players to face a tough choice: should they pro-

side to play, a difficulty level, and from duce more units, or invest in the possibility of being able to produce better ones through research? There is also a robust scenario editor included with the game, and a number of new scenarios have been posted to the Internet. Also, battlefront has signaled its continued support of this game by releasing a multiplayer patch recently online. The only real negative aspect is that the game can get bogged down a bit towards the end, when there can be up to

a hundred or more units in

Summary: Like Panzer General, Strategic Command is a modern day classic wargame. It is easy to learn, but offers so many user options that it has great replay value. This is truly a game that you will likely still be playing several years down the road.

- Technology.talk - Spam Spam Spam...Satisfying A Willing Audience -

In the quirky Paul Thomas Anderson film "Punch Drunk Love", jumpy, neurotic loner Barry Egan (played intensely by Adam Sandler), seeking female companionship, called a \$1.99 per minute phone sex line, something he thought would also offer anonymity and safety. He did this in spite of having been offered live companionship in the form of Lena Leonard, played by the fetching Emily Watson.

The question, why would Egan make that decision, is directly related to the question, why are spammers so successful? And that question is related to this question: why can't we stop Central and South American countries from exporting so much heroin and cocaine into the USA?

Everything points to human behavior.

Spam is our current national obsession. That obsession will pass, like everything else does in this country, but until it does, we are stuck with it as a prime topic of news and conversation.

Spam is not about technology; it is about people. Which brings me back to the hapless Mr. Egan, for whom telephone technology was the safer, less potentially humiliating choice for nothing more than a chat with a woman. Indeed, he made his selection, and the phone sex industry benefited.

Consider Barry Egan as symbolic of those who respond to spammers' pitches. And, respond they do.

The positive spam response rate is 1

in 10,000, or .0001 percent. The spammer I know personally sends 33 million messages each month, a comparative lightweight given others in his trade. Do the math: 33,000 people a month flash plastic to his clients, usually for products that cost more than \$10. This fellow takes his cut, which keeps him comfortably in new cars and hors d'oeuvres. Although he's a pauper compared to coke and heroin pushers, he does all right.

Again, everything points to human behavior, and it's humans who are needy, desperate, alienated or who otherwise feel that they are lacking in something who respond to spam.

I have a cousin who once told my mother, "Aunt Suzanne, I learned (from a college psych course) how to separate people from their money and I am going to devote my life to it." That was in 1968.

And so he has. My cousin has dedicated his every waking moment to direct mail marketing. He knows just exactly how dissatisfied we are with ourselves, especially in our most private moments, alone, just out of the shower, observing ourselves in the mirror and rejecting everything we see, from our physical appearance to our bank accounts to our relationships. Inside and out.

We have given my cousin sufficient motivation to peddle enough dissatisfaction-numbing junk, including "good luck" pyramids under which too many people have sat (to absorb good luck, no kidding...and he sold a zillion of them), to enable him to pur-

chase, with cash, a 26,000 square foot, four story home, gated within a gated community. All \$16 million of it. And this was before the advent of spam.

The geeks are trying mightily to employ technology to battle human behavior. How naïve. They are investigating everything from having computers perform math equations each time the computer spits out an e-mail message to heuristic methodologies that try to figure out if "Hi, from an old friend" is or is not spam. The government is even considering an e-mail stamp costing one one-hundredth of a cent. Some wags think that receiving too much spam will deter e-mail. Ha! Charging people for e-mail is what will kill e-mail. But, who will get the money and what will they do with it? And what will keep the miniscule charge from ballooning over time?

Policy makers are also considering antispam laws. Does anyone seriously think that will slow the flow of spam? If so, think again. We have laws against murder and fascinating technical wizardry to fight it. "C.S.I.", television's most popular show for the past two years, is about the uphill battle of technology vs. murderers. Yet, people still commit murder every day and many of them never face justice.

But the legal folks forge ahead. In a sort of perverse twist on today's priorities, it might become easier to commit and get away with first-degree murder than to send spam. That tells us where our national concerns lie.

legislation sound impressive, but drug sellers and murderers (and even spammers) know that neither has ever stopped all of them. Ironically, many antispam technologies might even increase the amount of spam. With a few programming commands, spammers could establish technological work-arounds that include tripling the amount of spam, confident that some will get through if only by overwhelming a system.


On the legal front, spammers who do not fake headers and do offer legitimate merchandise will, in fact, win any attempt to blacklist them or stop them as they perform what really is an alternate form of advertising. Pass all the laws you want, or have some overzealous programmer keep mass e-mail sent by General Foods or P&G from

getting to millions of addresses, and those who fiddle with the corporate supergiants will find themselves buried in hundreds of thousands of dollars in litigation fees and lost cases. Advertising is advertising, and don't ever bet against a determined, billion-dollar multinational corporation.

Remember that the Internet is life's intersection of people and technology. Ending spam (or illegal drug use) means coming to grips with those who respond to it. When they feel that they don't need the products that spam brings, then spam will stop because the purveyors will find themselves without a market.

But until that happens, you might as well quit whining and install the spam filter that suits you best.

- Has Your Web Surfing Seemed Slower? -

Recently, I found that my Internet access seemed sluggish, with pages loading more slowly then usual. I also had some other problems, which I have not had in the past, such as errors when burning CDs, or lockups when loading a recorded CD, or viewing multimedia files. I would now also sometimes get a "blue screen of death", the infamous blue window telling me that "IEXPLORE caused an invalid page fault", which often required a reboot to clear the locked computer. Other errors that occurred were "This program has performed an illegal operation and will be shut down", "Rundll32 caused an invalid page fault in module Unknown at 0000", and other similar errors.

To try and solve the problem, I reviewed any changes I had made to my machine. I had not recently added any new hardware. Diagnostics on my Internet connection showed a typical connection speed and throughput, so that was not the problem. Scandisk showed no hard drive errors, and there was no significant disk fragmentation to hinder performance. Other than daily updates, I was using the same version antivirus as usual. I ran an online virus scan at www.housecall. antivirus.com just to see if a virus or Trojan had slipped by my antivirus software between updates, and my computer was free of viruses and Trojans, either of which could have caused the problems. Then I updated and ran my favorite spyware checker, Spybot Search and Destroy, available for free from its website at spybot.safer.networking.de and it found a new "browser helper" called "New.Net" had somehow been installed recently. This spyware is somewhat benign, downloading and installing its updates silently in the background, while enabling access to non-standard, upper-level Internet domains. I allowed Spybot to remove the New.Net files from my computer.

Some quick online research on New.Net uncovered several interesting tidbits about this pest. Microsoft recently (June 4) posted a Knowledge Base article about New.Net, labeled KB302463, which described many of my problems exactly. Microsoft told about the problems with New.Net, and how to resolve them. The support small (800k), excellent, free utility section of another excellent spyware killer. PestPatrol. available from www.pestpatrol.com, indicates that New.Net has been known to crash Internet Explorer regularly.

About the only new software I had installed recently was the latest version of RealOne, the popular free multimedia player that I had downloaded from Real Networks, www.real.com. I had been trying to manipulate some unusual audio formats, and the new version of RealOne was listed as being capable, so I downloaded it and installed it. It was shortly after installing RealOne that I started having trouble web surfing and Now, I can play my streaming formats burning CDs. According to PestPatrol, RealOne is one of many programs that installs New.Net.

Looking up RealOne issues on the search engine Alltheweb, I found many references to problems similar to mine, and that the effective way to resolve the conflicts was to also remove RealOne from the computer. RealOne, in addition to being a comprehensive multimedia player also tries to read or write any CD inserted, as well as intercepts "calls" for other multimedia functions. According to the reports, this can cause the sluggish performance issues I encountered. I uninstalled RealOne using Microsoft's integral uninstall function by clicking on My Computer – Control Panel – Add/Remove Programs, clicking on RealOne, and uninstalling it. Almost immediately, my performance improved to where it was prior to the installation of RealOne, and my lockups and page faults were gone.

I was now back to my original need for a full-functioned multimedia utility. I have Microsoft's Windows Media Player, but I do not use it because of some of the performance and privacy issues associated with it. The need was promptly satisfied by downloading the latest version of a discussed previously in this column, Irfan View, written by a Bosnian computer science student. Available for download at www.irfanview.com, this small program has enormous capabilities. If the optional "plug-ins" are installed, Irfan View can play or manipulate virtually any multimedia format, including images, audio, and video. Streaming media, including real player format, QuickTime, and other video formats are also supported with the available plug-ins. I recommend that Irfan View be installed, and then the Irfan file "ALL Plug-Ins" be downloaded and installed.

without the degradation in performance I had with RealOne. Irfan View is written in tight code, which utilizes fewer resources such as memory and processor time, than its larger competitors.

If you are having similar sluggish performance while surfing the net, playing or burning CDs, or using streaming media, consider removing RealOne, and using Irfan View with its plug-ins. Also scan for viruses and spyware, as I did, and run Scandisk and Defrag. While not a cure-all for performance problems, this might be an easy solution for many of the problems that "we" are having.

*What's Going On Your Web Site?

If you have a Web site, it often helps if you know all the statistics about the visitors. One problem though, if you're using the free space given to you by your ISP, you probably have no access to the log for it (and can't use this product). On the other hand, if you have a paid Web space, usually you have access to the server log for your site. You should find out if your server log is accessible. You could analyze things the hard way and download the log file, then sift through it manually to see what you can determine. Sure it will work, but it's time consuming. I know in my case, I'd like to know which files were hit, and for how long.

Next, click the Compatibility tab as described in the first part of the tip and pick an older version of Windows from the drop box. Hit OK.

Now, double-click the Setup.exe program and setup should run. With any luck, you'll be able to install the software now.

Customize Internet Explorer 6 Toolbar

You can choose which features you want on the Internet Explorer 6 toolbar. If you want to simplify the toolbar, you can remove icons, change right. to smaller icons, or remove the text labels displayed next to the icons. To customize the toolbar:

- 1. Right-click the Standard toolbar, and then click Customize.
- 2. In the Text options list, click No text labels to remove them.
- 3. In the Icon options list, click Small icons to change the default setting.
- 4. In the Current toolbars list, click any icon that you want to remove, and then click Remove.

To keep your changes safe, right-click That's it. Now, just use the "List fonts the toolbar again, and make sure to select the Lock Toolbars check box.

- Microsoft Swats at Stealthy Web Bugs -

Attributed to "Thomas Fitzgerald", From off the Internet — Original source unknown

Privacy advocates say a shift by Microsoft could effectively marginalize a particularly intrusive use of Web bugs, the tracking and profiling devices used by online marketers and spammers.

Last month Microsoft retooled its Hotmail service, adding a feature that allows users to block Web bugs placed inside e-mail messages. A similar option exists in the most recent version of Microsoft's widely used Outlook Express e-mail program, and the company says the next release of its other e-mail program, Outlook, will block the tracking mechanisms by default.

"For consumers concerned about being tracked, we are giving them the flexibility to turn this new feature on or off," said J. C. Cannon, a strategist in the corporate privacy group at Microsoft.

Web bugs, which online marketers refer to as pixel tags, are used by creators of Web pages and advertisers to keep track of visits to a page. Often, the images are so tiny that they are invisible.

Creating a Web bug is a relatively simple technique that takes advantage of log entries generated automatically when a viewer calls up an image on a Web site. The site's logs capture the visiting computer's Internet Protocol address, the Web page viewed and the time

Embedding a Web bug in an e-mail message enables the sender, by means of the same logging technology, to capture information about the computer that received the message, including its I.P. address. Marketing companies and spammers use such messages - often called HTML mail, for hypertext markup language, the Web's lingua franca - to gather information about responses to the messages they send. HTML mail may also contain links to Web pages that contain Web bugs, enabling marketers

to track those who click from the message to various Web sites.

Marketing analytics companies like DoubleClick and WebSideStory use HTML mail to provide this kind of tracking service to their clients. "It provides an understanding of the effectiveness of marketing campaigns," said Jay McCarthy, vice president for product strategy and chief privacy officer at WebSideStory. "Clients can better target their marketing." Mr. McCarthy said the e-mail enhancements by Microsoft could hinder the marketers. Privacy advocates, however, welcomed the changes, which would also block HTML ads and offensive images from unknown send-

"Giving consumers the ability to block HTML images and Web bugs from email is like adding windshield wipers to a car: a necessity that will make traveling - in this case, on the Internet - much more enjoyable," said Stephen Keating, executive director of the Privacy Foundation. "It also removes a tool from the spammers' arsenal."

To use the new Hotmail feature, click on Options, then Mail Display Settings. Then choose "Remove images until messages are viewed." In Outlook Express, go to Tools, Options, Read, then select "Read all messages in Plain Text."

If you use an e-mail program that does not have an option to block HTML images, another tactic is to view your messages when your computer is off-line.

With Outlook 2003, users will be able to use new junk-mail filtering features to restrict HTML in incoming messages. Content from external Web sites will be turned off by default, which means that if a user receives a message that includes a connection to a Web site, that connection will be blocked, said Samantha McManus, a Microsoft spokeswoman. In contrast,

mail from inside a business's Intranet or pictures sent inside e-mail are not blocked, she said.

Web bugs have become more common among Web sites seeking to monitor visitor traffic and tailor their pages to visitors' preferences.

Well-known businesses like Yahoo, Best Buy and Orbitz, the travel Web site, use the technique but disclose that they do so in their privacy policies. Most promise to not correlate tracking data to personally identifiable information that they may have collected like credit card numbers, phone numbers or e-mail addresses. When used in concert with third-party cookies from advertisers, however, some Web bugs (often the ads themselves) can log an individual's moves across sites that are tied in with the same ad servers.

Consumers who want to block Web bugs while surfing have several options. Ad-blocking services like Ad-Subtract (www.intermute.com) and Guidescope (www.guidescope.com) screen them. The use of such cloaking services like the Anonymizer (www.anonymizer.com) offers the protections of an anonymous I.P. address and the ability to block thirdparty cookies. Without knowledge of HTML coding, spotting a Web bug is not easy. But the Privacy Foundation offers a free bug-spotting program, Bugnosis, at www.bugnosis.org, adding that a new beta version of the program is now available.

Finally, users can consider deleting all cookies, then setting their Web browsers to block third-party cookies to weaken cross-site tracking. According to Richard M. Smith, a Boston privacy and computer-security consultant, about 80 percent of Web bugs are the type used by advertisers for cross-site tracking. "This will make them lose that cookie, which is very valuable," Mr. Smith said. "I recommend it."

Therefore, we need individuals who are skilled in either Visual Basic and/or JavaScript. Any knowledge of the Internet Explorer Administration Kit (IEAK) or the Netscape Client Customization Kit (CCK) would also be welcomed.


