Cryptocurrency & Blockchain

Cryptocurrency & Blockchain

... A Video presentation by Chris & Jim Guld

B Y NOW, MOST OF US have heard the name **Satoshi Nakamoto** and his involvement in creating the first decentralized cryptocurrency, Bitcoin, using a cryptographic hash function. And how ownership records of cryptocurrency are kept in a digital ledger, a decentralized data base called a "blockchain." But very few of us could explain what all that means. Tonight, we are consulting the Geek Squad, Chris & Jim Guld, to provide a palatable explanation of both cryptocurrency and blockchain.

Why should we care? Cryptocurrency may be difficult to wrap your head around, but it is all around us now and spreading fast; not just in the US, but internationally, and in our own neighborhoods. Governments and large banks are paying attention to this entirely new asset class. Companies that currently accept cryptocurrency include: Paypal, Starbucks, NewEgg, Home Depot, Amazon, and the list keeps growing. Did you know there are several Cryptocurrency ATMs in the Dayton area?

As nationally known seminar presenters, Chris & Jim have been professional computer trainers since 1983. From 2003 to 2017 they lived full-time in a motorhome and toured the country presenting technology seminars at RV rallies, computer clubs, and even people's homes. 
Mark e-mailed the trustees a report by Wordfence on the security of our Web site, reporting no threats.



Have you heard ...?

Ohio Wins Out over Forty states in Attracting Intel Chip Factory

Ohio offered \$2 billion in incentives to lure the Intel Corporation to choose the state to build its new \$20 billion chip manufacturing factory. The factory, to open in 2025, will employ 3,000, along with 7,000 additional workers during its construction. Ohio's development director has noted that the combination of tax breaks and incentives was the largest package ever offered by Ohio to attract a business. *Various press sources*

Right to Repair

The term refers to the concept of allowing end users, business users as well as consumers, of technical, electronic or automotive devices freely to repair these products in case of mechanical or technical failure. The idea is to render electronics easier and cheaper to repair to prolong the life cycle of the devices and reduce electronic waste. Do-lt-Yourself Repair of Apple Devices!

This month, Apple announced Self Service Repair, which will allow customers who are comfortable with completing their own repairs access to Apple genuine parts and tools. Available first for the iPhone 12 and iPhone 13 lines, and soon to be followed by Mac computers featuring M1 chips, Self Service Repair will be available early next year in the US and expand to additional countries throughout 2022. *Apple.com*

Framework Laptop

First units began shipping in July. This is the first laptop that offers you the freedom to customize, repair, and upgrade the unit without fear of voiding a warranty. Start with a thin, lightweight, high-performance 13.5" notebook. Choose the processor, memory, storage, and whether to fill the four expansion ports with adapters for USB-A, USB-C, HDMI, Display Port, MicroSD, or flash storage. It comes with Windows 10 Home or Windows 10 Pro. Pricing starts at \$999, though you can order the DIY edition and build it yourself for \$749. https://frame.work

Microsoft OneDrive Compatibility in 2022

OneDrive applications will stop synchronizing with personal versions of Windows 7, 8 and 8.1 on March 1, 2022. Windows 7 and 8 users will need to update or lose access. Microsoft explains the change is being made "in order to focus resources on new technologies and oper-

ating systems, and to provide users with the most up-to-date and secure experience". "Beginning January 1, 2022, updates will no longer be provided for the OneDrive desktop application on your personal Windows 7, 8, and 8.1 devices," according to Microsoft's Ankita Kirti.

The closure does not affect business users in the same way, with Microsoft saying that starting January 1, 2022, support for the OneDrive desktop application for business will be aligned with the Windows support life cycle.

Windows 7 and Windows 8.1 are in extended support until January 10, 2023, however Windows 8 reached end of support on January 12, 2016, meaning it no longer receives vital security updates that keep devices safe from the latest cyber threats. *Techradar.com*

Mobile Phone Museum

The museum was set up on line by British industry analyst Ben Wood who collected thousands of phones as a hobby. A launch event was held in London a few days ago where he proudly displayed some of the oldest and ugliest devices. The collection currently has over 2000 individual models from more than 200 different brands. Each donated device is catalogued, labeled, photographed, and stored in a secure facility. New devices are added on a daily basis. *BBC.com*

ABOUT THE DAYTON MICROCOMPUTER ASSOCIATION, INC. (DMA)

A BOUT FORTY-SIX YEARS AGO, a small group of computer enthusiasts from the Dayton, Ohio area gathered around a kitchen table looking at, and playing with, an early personal computer called the Altair 680 that one of them had purchased. This computer had been featured earlier on the cover of the January 1975 issue of *Popular Electronics* magazine. Paul Allen had shown the selfsame article about the Altair to Bill Gates, and later, they wrote software together for that computer. Still later — and still together — Allen and Gates founded the Microsoft Corporation.

Shortly thereafter, those Dayton-area computer enthusiasts joined with many others to form The Dayton Micro-computer Association (DMA), now one of the oldest (if not *the* oldest) continuously operating computer user groups in the world. Typically,



computer user groups, and the newer iteration, technology user groups, are volunteer-run operations. The DMA is an all-volunteer led, organized, and run 501(c)(3) non-profit organization.

Now, there are hundreds of computer (or technology) user groups in the world, all of which continue to foster improved communication between technological equipment and software publishers, and users of their products. User groups (both computer and technology) provide an environment where more experienced technology users introduce additional and advanced techniques to novices.

DMA offers both monthly General Membership Meetings, which cover new and innovative topics including a wide range of generic technological topics, and its Special Interest Groups (SIGs) which address concerns about specific technology interests. There are eight different SIGs sponsored by the DMA, covering such topics as the Linux operating system, various programming languages such as Python, the use of technology to investigate genealogy, and digital aids to investing. Neither SIG members nor attendees at DMA General Meetings need be members of the parent organization, though they are encouraged to join so DMA can continue providing its services to the public.

Annual dues for DMA membership, which have not been raised for decades, are \$25 for Regular Members, and \$12.50 for Family/Associate Members (someone living at the same address as a Regular Member). Nonvoting Student Memberships are *free* to students through age 22. Door prizes at General Meetings, picnics, banquets, and other DMA events, and both product and service discounts are available to all DMA members. ... TDB
